## [From bounty land records in the Library of Virginia]

I John Lord of King William County do hereby certify that Claibourne Morriss [sic] was duly enlisted for three years. I enlisted in 1779 and found the said Morriss in the Virginia State artillery, Commanded by Colonel Thomas Marshall, in 1780 I marched to the South & Morriss was left behind from sickness or some other cause that I can't recollect at present but I think from sickness. Given under my hand this 14<sup>th</sup> day of May 1813.

King William County to wit. John Lord came before me a Justice of the peace for the said County and qualified to the above certificate. Given under my hand this 14<sup>th</sup> May 1813
