Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Report upon the claims of the heir of David Lagrave, John B. Dehay and Alexis Brisson-- soldiers in the Illinois Regiment, for bounty land for their services

To the Governor Sir.

these soldiers are not named in the Illinois Pay rolls & muster Rolls, which have been preserved; and they are not named on the Army Register of the State line –

The Clerk of Monroe Circuit Court State of Illinois has certified that it was proved to the satisfaction of said Court, in open Court, that Michael Lagrave, John B. Dehay, and Alexis Brisson were soldiers in the Revolution, in the Illinois Regiment commanded by Colonel G. R. Clark [George Rogers Clark]; and that they served between 3 & 4 years, when the Regiment was discharged &c (see the certificate of David Nowlin, Clerk &c)

State of Illinois Monroe County

I, David Nowlin, Clerk of the Circuit Court of said County, do certify that it is proven in open Court, to the satisfaction of said Court – that Michael Lagrave, John B. Dehay and Alexis Brisson were privates in the revolution in the Illinois Regiment, commanded by Colonel George Rogers Clark; that they served between three and four years, when the Regiment was discharged, and that they never received a Warrant, or Warrants for the Bounty Land promised them, either on the part of the United States or the State of Virginia; nor did they ever transferred their claim to it, or them, in any manner whatsoever – save by will – the witnesses being under the impression that the said subscriber to the within instrument in Harriet's from the within named Michael Lagrave, John B. Dehay by Will; and from the said Alexis Brisson as the only heir.

In testimony whereof I hereunto subscribed my name and affixed my official seal at Waterloo this 12<sup>th</sup> day of September A.D. 1834
