Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.]

## [From bounty land records in the Library of Virginia]

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia Continental Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session 1781, that a Certificate issued on the 30<sup>th</sup> day of April 1785, in the name of Andrew Lee, as a Soldier of Infantry for £15.17.4, which Certificate appears to have been delivered to Colo. Cropper and was given for services prior to the 1<sup>st</sup> January 1782.

Given under my hand, at the Auditor's Office, Richmond, this 6<sup>th</sup> day of February 1834.

I certify that Levin Hyslop<sup>1</sup> who is a Revolutionary pensioner & a man of truth & veracity made oath before me that Andrew Lee of this County [Accomack County] enlisted in the 9<sup>th</sup> Virginia Regiment for three years & was captured at Germantown [October 4, 1777] & imprisoned & was in service & imprisonment for three to four years before he was exchanged. Given under my hand & seal as a Justice of the Peace in & for Accomack County this 21st January 1834 S/Wm R. Custis, JP

Robert Russell Senior<sup>2</sup> a Revolutionary pensioner & a man of truth & veracity came before me & made oath that he was well acquainted with Andrew Lee of this County & that said Lee enlisted for three years in the 9<sup>th</sup> Virginia Regiment & was captured at Germantown & imprisoned & was in service & imprisonment nearly or quite four years with him the witness. Given under my hand & seal as a Justice of the Peace in & for said County this 21 January 1834 S/Wm R. Custis, JP
