[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To his Excellency Governor Floyd

Petition for bounty land

The Heirs of Francis Lennis Lieutenant State Navy

This Officer's name has not been found in the Navy Journals, or papers concerning the Navy. It is not in the list of lieutenants in the Virginia Navy, which is appended to "minutes of the Navy Board, from March 1779 to June 1779," in the first auditor's office. There is no proof, that that list was full & perfect; but it is entitled to some respect.

For respectable witnesses prove – that Francis Lennis died sometime in 1779 or 1780, in the service of the State – and state that he was Lieutenant in the Navy: among whom his Commodore James Barron. ¹

These are all the facts. If your Excellency should think them sufficient to authorize and allowance of bounty land, the allowance should be made for the War. (There is no proof of the times, when this officer entered the service).

The affidavit of Courtney Brough aged 74 [? very faint] years taken this the second day of March 1834 before me William Hope, a Justice of the Peace in and for Elizabeth City County

The said Courtney Brough being duly sworn states that he well remembers Lieutenant Francis Lennis during the revolutionary War – The said Francis Lennis was lost at sea in the early part of the war whilst in service as an officer of the state Navy of Virginia.

I William Jennings² of Elizabeth City County do hereby certify that I was well acquainted with Lieutenant Francis Lennis. The said Lennis was lost at sea as the deponent has always understood and verily believes during the War of the Revolution. The circumstances is well
