Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Petition for bounty land

Daniel Linder – Soldier – Illinois –

One witness Jacob Vanmeter says that Daniel Linder was a soldier for a short time in the Illinois Country under General Clarke [George Rogers Clark], in his expedition against the Shawnees in 1782. – That he was in Captain James Patton's Company.

The Payrolls of Captain James Patton's Company (see Vol. 1, Illinois papers) prove that Captain Patton commanded a Company of militia ordered into service for the particular Expedition against the Shawnees: and that Daniel Linder was a Sergeant in the Company; and was not in the Illinois Regiment.

State of Kentucky Hardin County

I Thomas Morrison a Justice in the County in the State of Kentucky do hereby Certify that Jacob Vanmeter² is a credible witness and that he personally appeared before me in my County aforesaid and made oath that he was well acquainted with Daniel Linder who was a soldier under General George Rogers Clark in the year 1780 and he was a private in Captain James Patton's Company and that the said Daniel fell in the ranks at the Falls of the Ohio and went one expedition against the Shoney [sic] Indians, under the command of General George Rogers Clark and continued until the fall of the year 1782, and this deponent further states that Daniel Linder is now living in the County of Hardin in the State of Kentucky and that he is the same Daniel Linder.
