[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[From rejected pension records in the Library of Virginia]

I Elkanah Andrews, ¹ aged 67 years & upwards do hereby certify that I was a sailor in the Virginia State Navy during the war of the revolution and served on board the State armed vessel called the "Accomack" & for my services on board that vessel a warrant for bounty land was issued in my favor: I further certify that I was well and particularly acquainted with Daniel Litchfield and that whilst I served on the Accomack as a sailor that the said Litchfield served as a midshipman on board the armed vessel called the "Diligence" which belonged to the Virginia State Navy – I further certify from my own distinct recollection of the fact, that before the "Accomack" and the "Diligence" were launched that the said Daniel Litchfield was a midshipmen in the Virginia State Navy, and that he kept guard, along with others, whilst the said vessels were being built, to prevent the enemy from burning them; and that after they were launched the said Litchfield was assigned to the "Diligence", and I do further certify that he rendered at least three years continued service in the state Navy as a midshipman – the Accomack & the Diligence were often in harbor together & from that circumstance and from my previous & subsequent personal and neighborly acquaintance with the said Litchfield I cannot be mistaken or in the least doubtful as to the nature & length of his service – he was in service before the Diligence was launched & continued in service, uninter [paper cuts off at this point at the bottom thereof]
