Bounty Land Warrant information relating to Jacob Locket [Lockett] VAS960 vsl 5VA

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

I do hereby Certify that Jacob Locket Enlisted as a Soldier under Captain Charles Flemming [Charles Fleming] of the Seventh Virginia Regiment the first of the year 1776 for two years. Sometime in the spring 1777 then the said Locket Reenlisted for three years in the same Company and same Regiment the said Locket served as Soldier & Sergeant until 1779 at which time I was ordered to the South and left him to the North where he became [several indecipherable words] Eye. Given under my hand this 31st of October 1811

It appears by reference to the books of this office, that on the 22nd of March 1784, pursuant to a

certificate from the Governor and Counsel, dated the 26th of March 1783, a warrant for 100 acres issued to Jacob Lackett, for his services as a private of the Continental [Army] for 3 years. It does not, however, appear that any warrant has issued from this office for the military services of Jacob Locket.

There is nothing filed or of record in this office that will positively show to whom the warrant above alluded to was delivered. The usual note is made on the Military Register which was of served at the time when this warrant issued – which merely serves to show that the same did issue but not to whom delivered. It appears to have been the practice of the Register to deliver those warrants to any person applying without requiring any authority in writing, until about the year 1790.

I do hereby Certify that Jacob Locket listed as a Soldier in Captain Charles Flemming's Company of the Seventh Virginia Regiment in the first of the year 1776 for two years. Sometime in February 1777 [paper damaged and text illegible for one line] which time said Locket served as a Soldier & Sergeant until 1779 when I was ordered to the South when the said Locket became no more under my [illegibly faint word].

This day Robert Flippin¹ made oath before me Anderson P Miller a Justice of the Peace for the said County, that he was discharged from the service of the United States at Lancaster in Pennsylvania on the second day of March in the year 1780, and at that time Jacob Locket was in the service of the United States and acted in the capacity of Sergeant, and that the said Locket proceeded from that place about that time to Frederick Town, Maryland with British prisoners, and further saith that he was acquainted with the above named James Taylor, whose name (& certificate) is annexed hereto and that the said Taylor served in company with the aforesaid Jacob Locket. Given under my hand this 11th day of October 1811.
