The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

The Affidavit of William Logwood in his sixtieth year saith that he (this affiant) was well acquainted in the family of Benjamin Lockett deceased who had seven children reputed to be his to wit, Winnifred, Richard, Benjamin, Francis, Charles, Mary and Archibald of which, Richard Lockett was reputed to be the oldest son and heir at law and obtained a Negro woman that belong to Archibald Lockett who died in the service of the United States in time of the war with Great Britain the said Richard obtained said Negro in the lifetime of his said father Benjamin Lockett the said Richard is since deceased and has left ten children reputed to be of his, to wit, Mabel, David, Edmund, Daniel, Jeremiah, Josiah, William, Rosah, Jesse and Archibald which are the heirs and Legatees of the said Richard Locket, Deceased

Be it remembered that on the day & year aforesaid Edmund Lockett presented to me a certificate with the signature of William Cunningham in the following words, to wit "I do hereby certify that Archibald Lockett enlisted a soldier in the Continental Army and in my Company in the first Regiment in August 1776 for the term of three years, and died in the service in the year 1777.

Which said Certificate and signature thereto subscribed I am well assured is in the hand writing of William Cunningham whose handwriting I have for many years been well acquainted with, and I very [verily] believe as well from general information of his neighbors as from his own, he acted as a Captain in the first Regiment in the Continental Army.

The Affidavit of Mary Watkins formerly Mary Lockett this affiant saith that she is one of the reputed children of Benjamin Lockett deceased, and that there were six others reputed to be the children of the said Benjamin deceased (to wit), Winnifred, Richard, Benjamin, Francis, Charles and Archibald, that Archibald about the commencement of the war, between the United States of America and Great Britain enlisted and went into the Army, from which he never has returned, as this affiant knows & but has been informed often heard Brother Archibald died in the service (which information this affiant very [verily] believes) and that her Brother Richard Lockett was reputed to be the eldest son of her father, and that her brother Richard has since deceased as she has been informed, and verily believes and has left ten children (to wit) Mabel, David, Edmund, Daniel, Jeremiah, Josiah, Rodah, William, Jesse and Archibald which are the reputed children and Legatees of the said Richard Lockett, and further saith that her brother Richard Lockett [paper damaged and text missing] a Negro woman left [paper damaged and text missing] at law many years before the death of [paper damaged and text missing] [the image of this document cuts off at the bottom thereof at this point]
