Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## [From bounty land records in the Library of Virginia]

State of Virginia Accomack County SS

John Bull aged sixty-one years this day personally appeared before me William R Custis a Justice of the Peace for said County and made oath that in the Revolutionary War and subsequently he was well acquainted with Thomas Lumber who was a Gunner's Mate on board the Galley *Diligence* commanded by Captain Johannes Watson and belonging to the Navy of the State of Virginia. The said Thomas Lumber was first a Seamen on board said Galley and on the appointment of William Lumber as Gunner the said Thomas Lumber was appointed Gunner's Mate and continued in that station until the Galley was laid up near the close of the War. The deponent was frequently on board said Galley and saw the said Thomas Lumber engaged on board and he knows said Thomas Lumber was employed on board said Galley the whole time she was in Service. How long this was the Deponent cannot positively say, but he is satisfied it was more than three years. Given under my hand this 5<sup>th</sup> of March 1831

Custis Bull aged sixty-seven years made oath before me Jno. G. Joynes a Justice of the peace that he knows all the facts set forth in said Deposition of John Bull – he and the said John being brothers and frequently on board the said Galley together, except that this deponent cannot positively say whether the said Thomas Lumber was a Gunner's mate or Boatswain's mate, he [several words too faint to discern. He well recollects that said Thomas Lumber was an officer in said Galley and was either a Gunner's Mate or Boatswain's Mate, and he is not certain which.

Bowdoin Snead aged seventy-one years personally appeared before me and made oath that he was well acquainted with the within named Thomas Lumber and knows that he was in service on board the Galley called the *Diligence* belonging to the Navy of the State of Virginia and commanded by Captain Johannes Watson. The deponent's brother was Surgeon of said Galley and the Deponent often went on board to visit his brother and from his own observation

he is satisfied that said Lumber was in service the whole time said Galley was in service – but at this distant time he cannot positively speak with precision as to the length of time nor can he say whether said Lumber was an officer or not – this  $5^{th}$  March 1831
