Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## Widow's Bounty Land Claim

State of Virginia Goochland County: SS

On this 18<sup>th</sup> day of April 1855 personally appeared before me a justice of the peace in and for the County and State aforesaid, Elizabeth Hicks aged 87 years, resident in Goochland County in the State aforesaid, who being duly sworn declares that she is the widow of Meshach Hicks deceased, who was a \_\_ in the company commanded by Captain \_\_ in the \_\_ Regiment of \_\_ commanded by \_\_ in the war of the American Revolution, that her said husband enlisted in Goochland County at \_\_ in the State of Virginia on or about the \_\_ day of \_\_ 17\_\_, for the term of \_\_ and was honorably discharged at \_\_ on or about the \_\_ day of \_\_ 18\_\_, as will appear by the Muster Rolls of said company.

She further states that she was married to the said Meshach Hicks at Goochland County on the \_\_ day of \_\_ one Reuben Ford a Baptist Minister and that her name before her said marriage was Elizabeth Moreland; that her said husband died at Goochland County on the \_\_ day of \_\_, 1826, and that she has remained a widow since his death.

She makes this declaration for the purpose of obtaining the Bounty Land to which she may be entitled under the Act passed March 3<sup>rd</sup> 1855 never having received Bounty Land or knowing that she is entitled except for the above service, and she believes that no Bounty Land was ever received by her said husband. She hereby revokes any application for Bounty Land previously made, or that may have been heretofore presented in her name, and she does by these presents constitute and appoint Charles C. Tucker of Washington D. C. her true and lawful attorney to prosecute the above mentioned claim and to receive for her benefit the Bounty Land Warrant to which she may be entitled.

Philpotts a resident of Goochland County, in the State above named and Margaret W Philpotts a resident of Goochland County in said State, to me known as credible witnesses, who being duly sworn declared that they are personally acquainted with Elizabeth Hicks widow of Meshach Hicks who has made and subscribed the foregoing declaration, that they were personally acquainted with Meshach Hicks and his wife during the lifetime of the former and know that they lived together as man and wife and to be so reputed, and they believe that the husband of the said Elizabeth Hicks was the

identical person who performed the military services mentioned in the above declaration: that the above named Meshach Hicks is now dead, and the said Elizabeth Hicks has remained a widow since his death: And they further swear that they are disinterested
