Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

This may Certify that John Nunaley enlisted in the 2nd Virginia State Regiment as a Sergeant for three years, – prior to January 1777. That he exchanged with a Soldier of the 15th Virginia Continental Regiment who was also for three years from December 76; on or about the 10th of January 1778. That he reenlisted for the War and said Regiment on the 19th day of December 1778 – as a Sergeant. He continued to serve as a Sergeant until the first week in January 1782 when he was transferred to Armangs [sic] Legionary Core. That he is since Dead while in the Army –
