Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." ## Granville County North Carolina January 2nd 1801

Sir

I have taken the liberty to enclose to you a power of attorney respecting the lands do my brother Thomas Hogg deceased for his services in the late war with Great Britain, and to ask the favor of you to obtain a warrant for his portion thereof and either keep it in your possession killed you return to this State, or forward it to me by some earlier opportunity.

My brother Thomas held the rank of Major till about the end of the War, when he succeeded to the rank of Lieutenant Colonel, & whether he will draw agreeable to the former or latter rank will be known I presume by the records in the War Office, —

The changes which are likely to take place, as well in our domestic situation as with regard to our foreign relations for bode a pleasing prospect to the agricultural interest, and I hope all well tend to promote the welfare of every Citizen of the United States – New Tobacco has taken a rise from 18/ to 28/ [indecipherable] this appears to have been the result of news of peace with France, though nothing official on this head has reached us as yet, –

I hope Sir, that you will pardon me for the liberty which I have taken in troubling you with this business and wishing you health, prosperity & and agreeable return home, I am with great respect Sir,

To all persons to whom these presents shall come, –

Know ye that I Samuel Hogg Executor of the last will and Testament of Thomas Hogg deceased who was in the service of the United States of America do hereby appoint & in power Nathaniel Mason Esquire one of the Representatives in Congress my true & lawful attorney to ask demand solicit & obtain in my name as executor aforesaid or in the name of the heirs of the said Thomas Hogg deceased or otherwise, but for the sole use & behoove of the legal Representatives of the said Thomas Hogg deceased and their heirs forever, from the United States, a Grant, or Grants, Patent or Patents, Warrant or Warrants for all the lands which the said Hogg was (or his legal representatives are) entitled to, for his services as an Officer in the Army of the United States of America for during the War, or for any other time or service in the war with Great Britain, & an attorney or attorneys under him the said Nathaniel...etc.


State of North Carolina

Know ye whom it may concern

That we William Polk of the City of Raleigh and Samuel Hogg of the County of Granville in the State aforesaid Guardians of Samuel Hogg, Junior & John Barnet Hogg sons & heirs [of] Thomas Hogg a Major in the Army of the United States in the line of North Carolina do constitute and appoint and by these presents have constituted and appointed the Honorable Nathaniel Alexander our lawful attorney, ...etc.

In witness whereof we have hereunto set our hands & seals this 17th day of November 1803

Dear Sir

Will you be kind enough to inform me whether Major Thomas Hogg or Captain Thomas Hogg of the Continental line on Continental establishment of the State of North Carolina had received his commutation and also the United States Bounty Land or his Depreciated pay. If he has received either pleas in and for many by home drawn, Time & place – also whether the depreciated pay was paid in the State of North Carolina or at Washington City immediately after the War, also Captain Samuel Hogg who was and Officer of the Continental line on Continental establishment in the Revolutionary War, of the Virginia Line. He and his brother both served during the Revolutionary War – please to inform whether Captain Samuel Hogg has drawn his United States Bounty Land and also his Commutation.

Major Thomas Hogg was my Father & Captain Samuel Hogg his brother and I believe I am with my brother's children the only heirs at law of both.

You will confer a particular favor writing me immediately.
