State of Georgia County of Glynn: SS: I William Whig Hazzard eldest son and one of the heirs at law of William Hazzard late of the District of Beaufort South Carolina deceased do upon oath testify and declare that to the best of my knowledge and belief the said William Hazzard was a Lieutenant in the Army of the Revolutionary War in the South Carolina line on Continental establishment and served as such to the close of the War: Also I do further testify and declare that I have never received a warrant from the United States for the quantity of land due the said deceased from the United States nor do I believe that he ever received it or transferred his right to it in any manner during his lifetime.

Therefore know all men by these presents that I Wm W Hazzard as aforesaid do hereby constitute and appoint Colonel Joseph Watson of Washington City my true and lawful attorney for me and in my name to demand and receive from the Secretary of War of the United States a warrant for the quantity of land due me in right of said deceased. Him

And my said attorney is hereby fully authorized and empowered to constitute and appoint one or more substitutes or attorneys under him for the special purposes therein expressed and the same to revoke at will.

State of Georgia County of Glynn: SS: Be it remembered that on this day, the third day of February A.D. 1827, there has been adduced to me satisfactory evidence to prove that W. W. Hazzard who has made the foregoing declaration on oath and has subscribed the power of attorney herewith connected, is a Son and one of the heirs of William Hazzard late a Lieutenant in the Continental Army of the revolution, and that the heirs of the said William Hazzard are six in number, to wit: his wife Sarah Hazzard, is two daughters Sarah H Montgomery and Mary E Hazzard residing in Savannah Georgia; his eldest son William Whig Hazzard and his second son Thomas Fuller Hazzard residing on St. Simons Island Georgia and his youngest son Richard

Edward Hazzard now in the U.S.A. and stationed in Washington City and that the above named persons are all the heirs of the said William hazard known to be living.

In witness of all which, I have hereunto affixed my hand and seal official, in my capacity of clerk of the Court of Ordinary this third day of February 1827

State of Georgia Glenn County: Personally came, and appeared before me Thomas F Hazzard one of the Honorable Justices of the Inferior Court for the County, and State aforesaid Sarah Waight formerly of South Carolina, but now residing on the Island St. Simons of the County, and state as aforesaid, who being duly sworn, deposeth and saith – That this Deponent is an [indecipherable word, looks like "acon" or "acove"] Sister to the said William Hazzard deceased Lieutenant in the Continental Army as aforesaid. And that she knows, and swears to the fact that the said William Whig Hazzard is the true, and legitimate son of William Hazzard deceased, formerly of the Continental Army. And that Sarah Hazzard is the widow of William Hazzard deceased, Thomas F Hazzard, Richard Edward Hazzard, Mary Elizabeth Hazzard and Sarah Catherine Hazzard Montgomery all his true, legitimate children
