Bounty Land Warrant Record of Robert Mebane BLWt1435-500 & BLWt2578-500 Transcribed by Will Graves rev'd 4/2/17

Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of South Carolina, Spartanburg District: 21st of July 1829

I Daniel Mebane ¹ (Brother) heir at law of Colonel Robert Mebane do upon oath testify and declare to the best of my knowledge and belief that Robert Mebane was commissioned a Lieutenant Colonel in the 7th Regiment North Carolina line on the 24th day of November 1776 and was promoted to the commission of a Colonel on the ninth day of February 1779 and that he continued to serve in the said Regiment until the 16th day of October 1781 when he was slain at the Siege of York in the State of Virginia where he was engaged in a conflict with the Common Enemy I further declare that I have never received a warrant for the bounty Land promised to him on the part of the United States nor do I believe that he ever received it or transferred his Claim to it in any [manner] whatever therefore I request the Honorable Secretary of war to have the same forwarded to me to Spartanburg Court House to the Care of Hugh Moore Sr. and this shall be his receipt for the same Sworn to and acknowledged in my presence.

A researcher who has studied the Mebane family in depth points out: "Col Robert Mebane was the son of Alexander Mebane Sr. of Orange Co., NC. He did not have a brother named Daniel. Col Mebane was in the 7th NC Regmt, but did not "continue to serve in said Regmt.....until 1781". The 7th was disbanded 1 June 1778 at Valley Forge and its remaining men placed in other units. See Heitman's Register of NC troops." This researcher points out that Daniel is a 'fraud,' because Robert Mebane did not have a brother named Daniel.
