Pension application of William Price BLWt1440-200 Transcribed by Will Graves f13VA 11/25/12

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Sir,

I have your esteemed favor of first Inst. and knowing the multiplicity of business at your hands, feel unwilling to tax you with an informal request – I have to inform you that the Treasury Department have allowed, and paid, me the 2 years pay as also for the last half year, as a Lieutenant = in the Revolutionary Army – this according to your views of the subject entitles me to a certificate from that Department which I beg the great favor of you to obtain for me & by its deposit in your office the Land Warrant you say is attainable.

I have duly received your esteemed favor of 10th Inst. Enclosing a Land Warrant No. 1440 for two hundred acres – granted to me for Services rendered as a Lieutenant in the Virginia Line, Continental service, for which, and for the trouble you have taken in my behalf – be pleased to except my thanks – I am Sir

By the Books of this Office it does appear that a military bounty warrant issued for the service of William Price as a Lieutenant for three years on the Continental line no other military warrant issued to said Price for service performed in the Revolutionary War

Sir,

In October 1809 an order of Council was made allowing me additional land bounty for one year and eight months service as a Lieutenant in the Continental line; the certificate for which has never been received by me, nor has any warrant for the same been issued by the Register. My Object now is to request that you will cause the usual certificate to be issued for the said allowance of one year and eight months additional.
