I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." At a Court held for Bedford County the 22nd day of December 1828

Satisfactory evidence was adduced in Court to prove that Samuel Martin is the son & one of the heirs at law in fee to William Martin Deceased late a soldier in the 14th Regiment of the Virginia line on Continental Establishment.

I Gustavus A. Wingfield Deputy Clerk of the County Court aforesaid do hereby certify that the above evidence is taken from the records in my office. In Testimony whereof I have hereunto set my official seal this 3rd day of December 1828

I Samuel Martin Son & one of the Heirs at law of William Martin do upon oath testify & declare to the best of my knowledge & believe that William Martin did enlist for the term of during the war in 1779 & served in the 14th Regiment under the command of Colonel Davis of the Virginia Line on Continental Establishment & that he continued in the service aforesaid until the close of the war in 1783 – I further declare that I have never received a warrant for the bounty land promised to William Martin on the part of the United States – nor do I believe that he ever received it or transferred his claim to it in any manner whatsoever therefore –

Know all men by these presents that I Samuel Martin [etc. legal power of attorney boilerplate language appointing Anthony Evans his attorney to receive the warrant for the bounty land due him].
