Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

## State of South Carolina City of Charleston

We John H Tucker, Harriet H Baker, and Harriet Hyrne Simons heirs at law of Major Massingbird Hyrne <sup>1</sup> do, upon oath, testify and declare, to the best of our knowledge and belief that Major Hyrne did enlist in 1775, for the term of during the war, and served in the Regiment No. One under the command of Colonel Christopher Gadsden of the South Carolina line; and that he continued in the service aforesaid until the end of the War, when he died. We further declare that we have never received a warrant for the bounty land promised to Major Hyrne on the part of the United States; nor do we believe that he ever received it, or transferred his claim to it in any manner whatsoever: therefore

Know all men by these presents, that we the above named persons aforesaid do hereby constitute and appoint Major James Hamilton of South Carolina to be our true and lawful attorney, for us and in our names to demand and receive from the Secretary of War of the United States, a warrant for the quantity of Land due to us as aforesaid: and our said attorney is hereby fully authorized and empowered to constitute and appoint one or more substitutes or attorneys under him for the special purposes above expressed.

<sup>&</sup>quot;Edmund Massingbird Hyrne became a major on 12 May 1779. He served as deputy adjutant general of the Southern Department from 17 November 1778 until the end of the war. He was wounded in Charleston on 30 March 1778 during the fighting at Gibbes Plantation. ... And 1781 he became an aid de camp to General Nathanael Greene. He was in the battle of Eutaw Springs and was in charge of the exchange of prisoners on the American side during 1781. He was the first Major in Maham's cavalry (South Carolina State Legion) on 4 August 1782. He resigned his commission from the State Legion on 18 September 1782. He became a brevet lieutenant colonel on 30 September 1783."

<sup>&</sup>lt;sup>2</sup> HAMILTON, James, Jr., a Representative from South Carolina; born in Charleston, S.C., May 8, 1786; completed academic studies; studied law; was admitted to the bar and commenced practice in Charleston; served in the War of 1812 as major; mayor of Charleston; member of the State house of representatives, 1819-1823; elected as a Republican to the Seventeenth Congress to fill the vacancy caused by the resignation of William Lowndes; elected as a Jackson Republican to the Eighteenth Congress, and reelected as a Jacksonian to the Nineteenth, and Twentieth Congresses, and served from December 13, 1822, to March 3, 1829; chairman, Committee on Military Affairs (Eighteenth through Twentieth Congresses); Governor of South Carolina 1830-1832; moved to Texas; appointed diplomatic agent of the Republic of Texas to France, Great Britain, Belgium and the Netherlands in 1839; was drowned on November 15, 1857, while on his way from New Orleans to Galveston. http://bioguide.congress.gov/scripts/biodisplay.pl?index=H000110
