I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honourable the President and Members of the Honourable House of Senate in the State of South Carolina

The petition of Daniel Mazyck Sheweth

That your petitioner was an Assistant to the Secretary's Office of the State for Six years, during which time your petitioner discharged the Trust and Confidence reposed in him –

That the present War having Commenced, and your petitioner being

Zealous for the rights and Libertys of America, and Wishing to Evince the Sincerity of such his disposition by his Exertions in the Field in Common with others

Gentlemen your pet.^r made a Tender of his Services, which being Accepted your petitioner in the year 1775 was Appointed and Officer in the 2nd Regiment of Foot, and your pet.^r presumes to hope that he acquitted himself to the approbation of his Superiors, and the Reputation of an Officer, he having been promoted to the rank of Captain –

That your pet.^r in the latter end of 1781, retired from the Army and as the Office of Register of Mesne Conveyances is now Vacant, your petitioner Emboldened (from his Service and the Injury his Circumstances have sustained) to Solicit your Honors Appointment, as Register, your petitioner being well acquainted with and Qualified to Conduct the Business with
