Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

From "Records of the Revolutionary War" by Saffell, 1894, pages 262-7 Thomas Ransdall was 1st Lieutenant under Captain John Marshall, in General Woodford's brigade, as it stood November 30, 1778. This entry shows that he was in Colonel Daniel Morgan's Regiment a part of his service and must have been at Valley Forge during a part of that Winter.

From Kentucky Yearbook of the S. A. R., 1894 2 1813: – page 307: – Captain Thomas Ransdall was one of the original members of the "Society of the Cincinnati" from Virginia.

He was granted a land warrant #167 for 4000 acres of land in return for his services in the Army. Order dated March 9, 1783


contains the following document relating to this veteran:

In the year 1775 I knew Thomas Ransdall who [several indecipherable words] in a Minute Battalion that [one or more indecipherable words] in the counties of Orange Culpeper and Fauquier in the year 1776 was appointed an officer in the Virginia Continental line and served to the end of the late war with Great Britain. Given under my hand this 31st day of October 18 07.
