## Pension application of Simon Alderson BLWT192-100 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Know all Men by these presents that I Simon Alderson of Hide [sic, Hyde] County and State of North Carolina late a Sergeant in the Continental line of the State aforesaid in the Service of the United States during the late War with Great Britain do hereby nominate and appoint make ordain & constitute William Blackledge of the County of Craven and State aforesaid my true and lawful attorney to ask for and received at the War Office or any other place a Bounty Warrant for Land due me as a Sergeant aforesaid, and do also empower him the aforesaid William Blackledge attorney or attorneys to make touching the premises herein ratifying & confirming all my said attorney or attorneys under him may do hereby.

Witness my hand & seal in New Bern in the County of Craven & State aforesaid May 26<sup>th</sup> one thousand eight hundred & one.

I Isaac Guion one of the Justices of the County aforesaid do hereby certify that I have been personally acquainted with the within named Simon Alderson for upwards of Seven years and that I do believe him to be the same man as his power of attorney denominates him to be. Personally appeared before me Isaac Guion one of the Justices of the County Court of Craven in the State of North Carolina John Davis – who deposed that he knew the within named Simon Alderson to be a Sergeant in the Second Regiment in the North Carolina Line in the War with Great Britain and that he is positive to his being the same as represented in the within power of attorney. Sworn to before me the  $26^{th}$  day of May 1801.

John Alderson Brother of Simon Alderson late a Sergeant in the North Carolina Line of Continental Troops came before me John Gray Blount one of the Justices of the County aforesaid and made oath that he attempted to get his Brother Simon to leave the Army when he was informed both by his Brother & Col Patton then Col of the Regiment that he the said Simon was enlisted for the War & he further knows from the said Simon & others that he was taken a Prisoner at Charleston at the fall of that place [Charleston South Carolina fell to the British on May 12, 1780].<sup>1</sup>
