Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Bee in behalf of the children of James and Peter Fayssoux deceased, Heirs at law of Dr. Peter Fayssoux deceased do upon oath testify and declare to the best of our knowledge and belief that the said Dr. Peter Fayssoux did entered the service in 1776 and served as a Surgeon General in the South Carolina Continental line; and that he continued in the service aforesaid to the end of the revolutionary war, his name being on the list in the proper Office in Washington. We further declare that we have never received a warrant for the bounty land promised to him on the part of the United States, nor do we believe that he ever received it, or transferred his claim to it in any manner whatsoever: therefore Know all men by these Presents that We, the said Barnard E. Bee, M. Foissin, H. Fayssoux, Barnard E. Bee Attorney for C. W. Stevens, and Barnard E. Bee in behalf of the children of James and Peter Fayssoux deceased, do hereby constitute and appoint Samuel Cheslyn Potter to be our true and lawful attorney for us and in our name to demand and receive from the Secretary of War of the United States, a Warrant for the quantity of land due to us as aforesaid as the Heirs at law of the said Dr. Peter Fayssoux deceased, and our said Attorney is hereby fully authorized and empowered to constitute and appoint one or more substitutes or Attorneys under him for the special purposes above expressed. Bee; and Sarah, the wife C. W. Stevens; Daughters of the said Dr. Peter Fayssoux, deceased, and the said Barnard E. Bee for William, Mary, Octavia & Thomas, children of James Fayssoux, son of the said Dr. Peter Fayssoux, deceased, and the said Barnard E. Bee for Edwards, Irvine, Ann, Peter, Callender, Clement, James, Mary, Martha, Rebecca & John, children of Peter Fayssoux deceased, son of the said Dr. Peter Fayssoux deceased. Also that the said Barnard E. Bee is the Executor of Mrs. Ann Fayssoux deceased, the widow and sole Executrix of the said Dr. Peter Fayssoux, deceased.
