Pension application of Everard Meade BLWt2063-300 Transcribed by Will Graves f11VA 5/19/13

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

[p 3: Certified copy of the last will and testament of Everard Meade Senior of Amelia County Virginia in which he names his wife Mary, sons David and Richard E. Meade, Joseph Eggleston, William T. Eggleston and Richard Eggleston as executors of his estate; his children Seth, Hodyah, Benjamin, Lincoln and Sally Meade. His will is dated January 13, 1801.]

[p 5: Certified copy of the last will and testament of Mary Meade in which she names her 2 sons Hodyah Meade and Benjamin L Meade her executors; she makes reference to the estate left her by her first husband Benjamin Ward; her daughter Maria Ward, afterwards Maria Randolph; her grandchildren Edwin Randolph, Edmund Randolph and Charlotte Randolph. Her will is dated September 1, 1830. And was probated in Mississippi, Wilkinson County.]

[p 11: Power of attorney dated August 30, 1834 given by Hodyab Meade and Benj. L. Meade, heirs at law of Everard Meade of Amelia County Virginia who entered the service in 1776 as a Captain.]

[From bounty land records in the Library of Virginia]

I do Certify that Everard Meade was appointed an officer in the Virginia Line in February 1776 & continued in actual service until May 1780 when he took a Seat in the Assembly and considered himself no longer in the Army he left the service with the rank of Major. Given under my hand this 3rd day of January 1784
