Bounty Land Warrant information relating to Samuel Morris BLWt214-100 f8VA Transcribed by Will Graves 7/19/13 supp'd 5/17/15

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

I do Certify that Samuel Morris took John Collets place in the Spring of the year 1779 who was a Sergeant in Captain Porterfield's Company in the 11th Virginia Regiment on Continental establishment and that the said Collet was enlisted a Sergeant for during the War. Given under my hand this 30th day of May in the year 1801.

The above is a Copy of a Certificate filed in the office of the Executive of Virginia on which a Bounty in Land Issued to Samuel Morris as a substitute to John Collet as therein stated. Richmond September 28th 1801

The Bearer Samuel Morris was a Soldier in the 11th Virginia Regiment commanded by General Morgan (the Colonel in the service of the United States) – at the close of the Campaign 1779 a considerable number of men who were enlisted for three years were discharged their terms of enlistment having expired at that period General Scott's Brigade was commanded by me, and I recollect discharging the said Samuel Morris as one who had served 3 years.

Given under my hand this 13th day of September 1793 S/ James Wood, late B. G.
