Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

The following letter dated May 3, 1937 appears in the file regarding the services of John **McNeese**

Dear Sir:

Reference is made to your letter in which you request information in regard to John McNees, who served as Lieut. in the North Carolina line, War of the Revolution.

The data which follow are obtained from the papers filed in the claim for bounty land based upon the military service of John McNeese or McNees in the Revolutionary War.

The date and place of birth and the names of the parents of John McNeese or McNees are not shown.

John McNeese or McNees entered the service some time in 1778, place not shown and served as Capt. in the North Carolina Line; length of service, until the close of the war.

The date of his death is not shown. It was stated that he was never married. Two sisters are named, Nancy, wife of Matthew Hill, and Hannah Jones, name of her husband not given. She was dead in 1836. The date of her death was not given.

January 1, 1836, Matthew Hill and wife, Nancy, Redding and Gatsey Jones, children of Hannah Jones, deceased, all of Greene County, North Carolina, applied for the bounty land which was due on account of the service of John McNeese or McNees, Capt. in the North Carolina Line. War of the Revolution.

Warrant No. 2147, for 300 acres of land was issued May 26, 1836, on account of the services of Capt. John McNeese or McNees, Capt. of the North Carolina Line, War of the Revolution. Said warrant was issued for the benefit of the above named heirs.
