Bounty Land Warrant Information relating to John Walker BLWt2230-100 f12VA Transcribed by Will Graves 7/25/11 rev'd 5/11/20

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Virginia: Charlotte County to wit:

I Littleton W Walker one of the Heirs at law of John Walker, do, upon oath, testify and declare, to the best of my knowledge and belief, that John Walker did entered the service the year __for the term of "for and during the war" and served as a Dragoon in the 3rd Regiment of Light Dragoons under the command of Colonel W. Washington [William Washington] of the State line of Virginia on Continental establishment, and that he continued in the service aforesaid until the close of the war –

I further declare that I have never received a Warrant for the Bounty Land promised to John Walker on the part of the United States: nor do I believe that he ever received it, or transferred his claim to it, in any manner whatsoever: therefore

Know all men by these presents, that I Littleton W Walker aforesaid, do hereby constitute and appoint William J. B. Bedford Esquire, my true and lawful attorney, for me and in my name to demand and receive from the Secretary of War of the United States a Warrant for the quantity of Land due to the heirs aforesaid: and my said Attorney is hereby fully authorized and empowered to constitute and appoint one or more substitutes or attorneys under him, for the special purposes above expressed – As witness my hand and seal this 26 day of April 1838 – Witness

Virginia to wit

At a Court held for Halifax County at the Courthouse thereof on Monday the 25th of June 1838 satisfactory evidence was adduced in Court to prove that William Walker, Littleton Walker, Richard Walker, Sherard Walker, Catharine the wife of William J. Brantley, Martha the wife of Samuel Silva are the only children and heirs of John Walker and late a soldier in the Revolutionary War

I William Holt clerk of the Court of Halifax County do hereby certify that the foregoing certificate is truly transcribed from the Records of my Office.

In testimony whereof I have hereunto subscribed my name & affix the seal of said County at my office the day and year above written.

Virginia, Charlotte County to wit:

I do hereby certify, that I was acquainted with John Walker late a Dragoon under Colonel Washington in the State line of Virginia on Continental establishment in the War of the Revolution, and know the fact that he enlisted for the war, and believed he served to the close – He died many years since, and left several children, the names of all of whom I do not recollect, but knows very well that Littleton Walker, William Walker & other children were his only heirs. I have seen the Certificate of Halifax Court as to Heirship, and believe, that the same contains the whole of the heirs & children of the said John Walker. I further certify, that I was a soldier at the time, and had every opportunity to know something of the services of the said John Walker in the Revolutionary war; and his family since the Revolutionary war – given under my hand this 20th day of July, 1839.
