Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." At a Meeting of the Justices of the Inferior Court of Ordinary purposes, on Monday the 6th of May 1839

Present Their Honors George W. Evans, William W. Hughes, Abel Lewis and Edmund Palmer Esquires.

Georgia Burke County. It being represented to the Court by Baldwin B. Miller Guardian for Robert J. & Sarah A. Morrison, that a Warrant of two hundred acres of land due his said wards from the United States in right of the Services of their late Grand Father General John Morrison as a Lieutenant of the Georgia Line of the Army of the Revolution which it is believed that the Order of Court Authorizing him as Guardian to sell the Real Estate of John B. Morrison does not embrace this being never in the possession or ownership of John B. Morrison. Whereupon it is ordered that the said B B Miller is authorized to sell, dispose of & assigned over the aforesaid mentioned claim in any way for the benefit and use of his said wards:

Georgia, Burke County. At a Court of Ordinary held in and for said County on the 6th of May 1839. On motion of Doctor Baldwin B. Miller Satisfactory evidence was adduced in open court to prove that Robert J. and Sarah Almira Morrison Minors of said County on the Children and only heirs at law of John B. Morrison late of said County Deceased who was the son and only heir at law of General John Morrison late of said County deceased who was reported to have been a Captain or Lieutenant in the Georgia Line of the Army of the Revolution and ordered to [be] certified accordingly.

I Edward Garlick Deputy Clerk of the Court of ordinary of the County of Burke, and State of Georgia do certify that the foregoing extracts from the minutes of said Court are true.
