[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Virginia Henrico County: At a County Court held in and for said County on the seventh of November 1842 on motion it was proved in open court to the satisfaction that Erasmus Kennon deceased of Mecklenburg County Virginia, Doctor George T Kennon of Henrico County Virginia, Commodore Beverly Kennon of Washington City, William H Kennon of Powhatan, Doctor Richard Kennon (deceased), late of Norfolk Virginia and Sarah S (deceased) wife of the late Commodore Arthur Sinclair are the children and only heirs at law of Richard Kennon (deceased) late of the Mecklenburg County Virginia who was a Captain of the Virginia Continental line of the Army of the Revolution. That George (deceased), Elizabeth B wife of Doctor Silas H Harris, Nancy wife of Oliver Kennon, Lucy wife of Edward a Williams, Sally wife of William D Ligon, Roberta, Richard and William Kennon, all residing in Mecklenburg County Virginia are the Children and only heirs at Law of Erasmus Kennon deceased. That George Kennan deceased son of Erasmus left two infant children one of whom is since dead the other Alice is only heir at law of said George, that Emily E is the infant daughter and only heir at law of Doctor Richard Kennon deceased and resides with her mother in Norfolk and lastly that Arthur Sinclair, Elizabeth wife of William C Whittle, George T Sinclair, William Henry Sinclair and Gilberta M Lafayette Sinclair are the Children and only heirs at law of the said Sarah S Sinclair deceased, the three males being officers in the Navy of the United States and the two females residing in Mecklenburg County Virginia, all of which is ordered to be Certified.

Loftin N. Ellett Clerk of the County Court of said County do hereby certify the foregoing to be a true copy from the records of the said Court.

In testimony whereof I have hereunto set my hand and affixed the seal of the said court at Richmond this 8th day of November 1842.

Warwick Camp/ May 22 1800

At the request of Colo. Richard Kennon, I have had a reference to papers related to the Revolutionary War. I was entitled to a Captaincy in the 5th Virg'a Regm't of that War, on the first day of June 1778, and Richard Kennon was a Senior Officer in that Regiment.

W. Bentley L Colo Com'dt [William Bentley S37745] [undeciphered] Regm't

I Rich'd Kennon state that after the reduction of the [undeciphered] Regiment [undeciphered] He was again called on to serve in the first instance by General [William] Smallwood, when he commanded [undeciphered] at Petersburg, that he engaged or rather offered to raise company of volunteers to serve during that occasion, but was told by Gen'l Smallwood, that he would prefer his services in another way, which was to be in the Gen'l family [i.e. staff], as he the s'd Kennon was well acquainted with the Country and people thereabouts, that he attended Col. George Gibson [BLWt1985-500] in an expedition below Petersburg and on all occasions rendered his services when called on [illegible] that he was again employed by Gen'l. Stevens [Edward Stevens VAS1922] before and after his retreat from Petersburg – and was on the day of the action at that place [15 Apr 1781] employed on a very dangerous [undeciphered word], reconnoi[page torn]ing [reconnoitering] the Enemy and gave the General the first notice of the intentions of the Enemy, and that he afterwards in the same year viz 1781 did duty at various times with detachments sent out by the Marquis Lafayette who succeeded Baron Steuben in the command of the Troops in this State.

Mr. Richard Kennon's first appointment as a Lieutenant was in the year 1775 – he was entitled to promotion in the early part of 1778, and became Supernumerary at the Arrangement of September 1778 [http://revwarapps.org/b161.pdf] – he was frequently called into service by the Continental Commanding Officers in this state, as stated by him in the above Certificate – his case appears to me to be exactly similar to those of Capt Briscoe [Reuben Briscoe BLWt81-300] & Lieutenant Hungerford [Thomas Hungerford BLWt934-200].

I do hereby certify that Richard Kennon entered the Service of the United States as Lieutenant in the fifth Virginia Regiment on Continental Establishment in the month of February One thousand seven hundred and seventy six, and was afterwards promoted to the Rank of Captain. Given under my hand this [illegible] day of July 1807.
