[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later intereenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[p 3: Power of attorney dated October 1, 1845 and filed in Fayette County Pennsylvania by John Harrison in which he empowers his attorney to pursue a claim for 200 acres of bounty land on his behalf as the heir of his uncle Battle Harrison as a Lieutenant who was killed in the battle at the surrender of Fort Washington on the 16th day of November 1776 at which time he was a Lieutenant in Colonel Stephenson's Rifle Regiment assigned to the quota of the Virginia Continental establishment. He signed this document with his mark.]

District of Columbia Washington County: SS

At and Orphans Court Held in and for said County on this 28th day of October 1845 on motion of Henry Northop, it was proven in open court to the satisfaction of the Court by the deposition of Captain Bedinger and a certificate from the Register of the Land Office at Richmond Virginia that Battle Harrison was a Lieutenant of the Virginia line of the Army of the Revolution and was killed at the surrender of Fort Washington on the 16th of November 1776 and it was further proven by the letter¹ of Battle Harrison from Columbus Ohio, and by the deposition of Crawford and Ann Springer² that William Harrison who was killed in Crawford's defeat [June 4-6, 1782] was the eldest Brother of Lieutenant Battle Harrison and that John Harrison now living is the eldest son of the said William Harrison, all of which is ordered to be certified.

Personally appeared Henry Bedinger³ aged eighty-four years and about seven months before me Tilotson Fryatt a Justice of the peace in and for the said County, and being duly sworn according to law saith that Battle Harrison entered Captain Hugh Stephenson's Company of Volunteer Riflemen about the first of June 1775, raised in said County, that he marched in this Company, with this deponent, to the Siege of Boston, that at the expiration of one year for which he had engaged or soon thereafter he was regularly discharged, then returned to Berkeley, was there appointed a third Lieutenant in Colonel Hugh Stephenson's Regiment of Riflemen, and annexed to Captain William Brady's Company of said Regiment, that on the 16th of November 1776 said Battle Harrison was killed in the Battle, and surrender of Fort Washington – and

State of Kentucky Harrison County Sct.

The deposition of Lawrence Harrison⁴ of said County taken before us the Subscribers two of the Justices of the peace therefore this 6th day of September 1786. This deponent after being duly sworn on the Holy evangelists of Almighty God Deposeth & saith that his brother the said Battle Harrison mentioned in the above power of attorney⁵ that the said battle Harrison went out at an early period of the late war as a Lieutenant in Colonel Hugh Stephenson's Regiment & was killed at the taking of Fort Washington in the year 1775 or 1776. That the said Battle Harrison never was married, that when he was killed he left three brothers then living to wit William Harrison, Benjamin Harrison⁶ and this Deponent, that William was the elder of the three, that the said William Harrison⁷ was killed by the Indians at Colonel Crawford's defeat in the year 1782 leaving the above named⁸ Andrew Harrison his eldest son & heir at law & further this deponent sayeth not – Given under our hands this the day & year above written

The above Lawrence Harrison the Deponent was and Officer in the Virginia line who served to the end of the war, and is deserving the utmost Credit. I also know that William Harrison was the eldest son and Heir at law of Lawrence Harrison the elder deceased who was father of the above Deponent.
