
[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Rockingham County September Court 1850

On the motion of John Fuls [? Feels?] Administrator of Benjamin Berry, deceased and one of the heirs at law of said deceased & others heirs at law of Benjamin Berry deceased is ordered to be certified that it has this day been proven to the satisfactory of the court that the said Benjamin Berry, late of this County died intestate in the year 1832 aged about 75 years, leaving the following children as his only heirs at law, to wit, McKinley, John, George & David Berry, and Ellen Swatz (formerly Berry) and rode Fuls [Feels?] (formerly Berry) that the said McKinley Berry has since died intestate leaving his wife Catharine, and his children Margaret Ann Trayer (formerly Berry), Phebe Jane Freed (formerly Berry), Elizabeth Dougherty (formerly Berry), Catharine Sinden (formerly Terry) and Archibald very as his heirs at law – that the aforesaid John, George & David Berry, Ellen Swatz, Rhoda Fuls, Catharine Berry, Margaret Ann Trayer, Phebe Jane Freeds, Elizabeth Daugherty, Catharine Sinden and Alexander Berry are now the only heirs at law of the aforesaid Benjamin Perry deceased,

[p 3: Power of attorney given by John S Berry heir at law of Benjamin Berry who was the only heir at law of Benjamin Kinley who was a Captain in the war of the Revolution; that Benjamin Kinley entered the service in the year 1777 for the term of during the war and served in the Continental service until he became a supernumerary officer.
