Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of Alabama like County:

On this 14th day of July A.D. 1856 Personally appeared before me a Justice of the Peace within and for the County and State aforesaid Morning Melton aged 104 years a resident of Pike County in the State of Alabama who being duly sworn according to law declares that she is the widow of Robert Melton Deceased who was a Private in the Company Commanded by Captain Shadrach Inman Regiment commanded by Colonel McKoy or McCoy in the Revolutionary War the year or place of being mustered into or out of Service not recollected but that they were citizens of South Carolina and said [service] was rendered in South Carolina her recollection is that he was mustered into service as a volunteer and was in a Battle at Demery Ferry [?]¹ on Savannah River as the Rolls will show having no discharge as she knows of. She further states that she was married to the said Robert Melton in Burke County Georgia on the 15th day of July 1770 by one Benjamin Davis JP and that her name before her marriage was morning Lewis that her said husband died in Pike County Alabama on the 4th day of August 1850. She makes this declaration for the purpose of obtaining the Bounty Land to which she may be entitled under the act 28th September 1850 or the Supplemental act to that act passed in 1856 and that she appoints William M. Johnson to Prosecute this Claim & receive the warrant if issued.
