Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Ohio Highland County: SS

On this 3<sup>rd</sup> day of June A.D. 1854 personally appeared before me Justice of the peace in and for said County, Robert Iron aged eighty-four years a resident of said County, who after being duly sworn according to law declares that he is the identical Robert Iron who was a private in Captain William Clendenin's company of Militia ordered into service by the executive of Virginia for the defense of Greenbrier and Kanawha Counties, in the Indian war, beginning in 1790 and ending in 1795.

That he volunteered at Leesburg in the County of Greenbrier for said service, and among other services set forth and declares that he served in Captain William Clendenin's company from the 15<sup>th</sup> day of March 1794 until the 20<sup>th</sup> day of January 1795, and was honorably discharged at Kanawha County, when General Wayne [Anthony Wayne] obtained a victory over the Indians, peace concluded and the news thereof reached the Garrison to which he belonged, and received a certificate of such discharge which has been destroyed in the lapse of time.

Has never received bounty land under any act of Congress.

He makes this declaration for the purpose of obtaining the bounty land to which he may be entitled under the act passed September 28, 1850. Silas Iron his son he hereby constitutes and appoints as his attorney to prosecute said claim and desires that a land warrant may be sent to him.
