The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Belmont, Union District 29 August 1804

Passing the other day through Winnsboro I communicated the contents of your letter of the 28<sup>th</sup> last May to Messrs. Buchanan & Moore, relative to their being no documents forwarded to support their claims to Lands as officers of the US during the last war – they said that General Winn informed them on his return, that they were too late, being barred by the act of Congress, that therefore they had not sent them forward. – I now enclose you the Certificate for the Buchanan's & Moore which they had preserved, & a new one for Moore as he had destroyed the one I had given him some time ago, thinking it useless on General Winn's information. –

Upon inquiry I find General Sumpter [Thomas Sumter] resigned before Captain Brown was out of Service, but I do not believe he can obtain any past or stronger Certificates than what I forwarded you some time ago.

I will accept of Mr. Michael Nourses offered to pay my taxes in the State of Ohio & will send forward money for that purpose by the first safe opportunity. —

Be pleased to observe that Hugh Milling's signature is in my handwriting to the note addressed to me by Moore & Buchanan, having added his name as a memorandum for whom I was to get also a Certificate. – Milling happened not to be present when they gave me the letter to me. Captain Milling's Certificate will be forwarded as soon as procured

You will please to procure for us Certificates of our rank, and time of service in the Revolutionary war; in order that we may be enabled to make a legal demand for the land allowed us for our services in the Army --

A power of attorney from us is in the war office in favor of General Winn, but without those certificates he cannot complete the business, also for Robert Buchanan who was a Lieutenant in the third Regiment and died during the time he was a prisoner of war


