Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Dear Sir,

It has not till within 5 or 6 months past, came to my knowledge, that the United States, have appropriated some Townships or allotments of land, in the Western Territory, for the service or use of the Officers and Soldiers of the revolutionary Army. Captain Marbury, informed me, about the time above specified, that Captain Meriwether through the application of General Meriwether, when a member of Congress, had received his Grant.


It is well known to you, that I was in the service of the United States, from the commencement of the War in the Southern States, until the close thereof -- I entered the first Georgia Battalion as Ensign, early in February '76, and rose by different grades to Captain, in '77, and therefore agreeably to resolution of Congress, I am entitled to Brevet rank as Major. By reference to the office of the Secretary of War, as also to the Books of John Pierce, Esq., the Agent for finally settling military claims further satisfaction, if necessary, may be obtained.

I have now to solicit your friendly aid in applying at the proper office, for such grant as I may be allowed; and upon obtaining enclosed it to me; If there is any choice, as to quality, situation, or distance, it is left to your direction; and any disbursements that you may make in the completion of the business, shall be thankfully reimbursed. I feel assured of your excuse [?] For the trouble I am about to give you, and am,

¹ MILLEDGE, John, a Representative and a Senator from Georgia; born in Savannah, Ga., in 1757; was tutored privately; studied law; admitted to the bar and commenced practice in Savannah, Ga.; served in the Revolutionary War and was one of the patriots who rifled the powder magazine in Savannah; narrowly missed being hanged as a spy; attorney general of Georgia 1780; member of the State general assembly for several sessions; elected to the Second Congress to fill the vacancy caused by the House declaring the seat of Anthony Wayne vacant, and served from November 22, 1792, to March 3, 1793; subsequently elected to the Fourth and Fifth Congresses (March 4, 1795-March 3, 1799); again elected as a Democratic Republican to the Seventh Congress and served from March 4, 1801, until his resignation in May 1802; chairman, Committee on Elections (Seventh Congress); Governor of Georgia 1802-1806; elected as a Democratic Republican to the United States Senate to fill the vacancy caused by the death of James Jackson; reelected in 1806 and served from June 19, 1806, until November 14, 1809, when he resigned; served as President pro tempore of the Senate during the Tenth Congress; one of the founders of the University of Georgia at Athens; died on his plantation near Augusta, Ga., February 9, 1818; interment in Summerville Cemetery. http://bioguide.congress.gov/scripts/biodisplay.pl?index=M000712 viewed 6/9/09
