[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Know all Men by these presents that I Mathew Irvine late a Surgeon in Col. Har[balance of name obliterated] Legion in the Continental Army for and in consideration of \$100 to me in hand paid by Peter Manifold the receipt whereof I do hereby acknowledge had to him by these presents doth grant bargain sell assign and transfer unto the said Peter Manifold all the lands to which I am entitled as surgeon aforesaid from the United States and all my right title interest claim or demand of to and in the same and every part and parcel Thereof -- To have and the whole all the said lands hereditaments and premises to him the said Peter Manifold and to his Heirs and assigns for his and their on the proper use and behoof forever. And I do hereby authorize and empower the said Peter Manifold to ask demand and receive from the Secretary of War of the United States or the proper officer all the Deeds patents and writings to the same belonging or in any wise appertaining.



I do Certify that I well knew and recollect Doctor Mathew Irvine joining our Troops and marching with them to Prospect Hill near Boston in the year 1775, and he was with the Army near New York in October 1776, at which time I was a Lieutenant in the Pennsylvania line, and was sent on command to Fort Pitt, which prevented my knowing anything further of the Doctor's service, but always understood he continued in service.



This may certify that I know the above Archibald Steele. He was an officer & went with

the first of our Troops to Boston & lives now in this City & is considered by the Government of the United States a man of such respectability as to appoint him one of the Superintendence of Powder & other Military Stores of the United States. I also recollect Doctor Matthew Irvine being very early with our Troops but have no particular recollection of him as to the rank he held until 1776 or in the year 1777, our Troops being frequently on difficult Commands, but remember he continued with us until he got an appointment as a Surgeon in the Corps of Horse commanded by Colonel now General Henry Lee. Mr. M. Irvine was a young gentleman from Ireland and brother of my Friend the late General William Irvine of the old Pennsylvania Line. Given under my hand the day and year above written.

Dear Sir

In answer to yours of yesterday reflecting Doctor Irvine's claim for Bounty land due for his Services as Surgeon to your Legion, from the State of Virginia –

I do Certified that Doctor M. Irvin Lieutenant Manning & John Gordon Lieutenant and Riding Master at the time they joined your Legion were returned as of the Virginia line at their request; as well as those Soldiers that your certificate mentions dated the 4th of January last – indeed I know of no exceptions to any of the officers of your Legion being returned from any other State, as the Bounty from this State was so much greater than any other State in the Union – I was Lieutenant & Pay Master to your legion at that time and returned the within mentioned at their request and with your approbation.

Sir.

I have received & attended to your letter of the 23rd of this month. As to that part of it which requires the names of the Officers & Soldiers of Lees Legion which were "credited to the quota of troops required from this state, and properly belonging to the same," I cannot reply with that certainty which you might expect, because I never knew whether they were so credited in the War Office. I only know, that at the last inspection of Lee's Legion just before the Troops in South Carolina were disbanded, the Officers & Soldiers whose names are enclosed were entered on the returns as being born in the State of Virginia. On these last inspection returns no other names than the enclosed were entered as belonging to or enlisted in the State of Virginia.

Captain George Handy & Doctor Matthew Irvine were not returned as Virginians, & neither of them were born in this State. Nor was George Painter, nor John Harrison, as to Daniel Snailbaker I can only say I see no such name on the returned; & Samuel Jess, John Woody & James Chambers are returned as born in New Jersey.

I have thus, Sir, replied to the different inquiries in your letter with as much accuracy as the papers in my possession would enable me, & take the occasion to subscribed myself, with the highest Esteem & respect

Sir,

2 days ago I wrote an answer to your letter of the 23rd March which I find you have not received, as Captain Manifold has just handed me your duplicate. I now [paper damaged and some text illegible] the 2nd instant & at the request of Captain Manifold to the address I will be more explicit as to the circumstance of the Quota. Whether the whole Legion was considered as part of the quota of the State of Virginia, is what I can neither affirm nor deny; because I never had any information as to that fact. I can only say that the Officers & soldiers whose names are enclosed, were returned as being natives of Virginia; & that others are stated on the returns as being born in New Jersey, Maryland &c. For what purpose this was done I do not pretend to inform you, as I was never made acquainted with the mode in which the Quota of each State was estimated. Captain manifold has shown me a certificate stating that Lieutenant Lovell was considered as belonging to the Virginia Line. Mr. Lovell was an Officer of Lee's Legion & was born in Massachusetts; & I should imagine every officer in the Legion might with as much propriety be said to be of the Virginia line as Mr. Lovell.

Doctor Irvine I believe was born in Ireland, & though he joined the Legion from the Pennsylvania Troops, he might with less difficulty have annexed himself to Virginia than Mr. Lovell. Perhaps all the officers might have been considered at the War Office as of the Virginia Line.

I have given this explanation of the request of Captain Manifold, although I am rather apprehensive of being both of fishes & tedious.

From the circumstance of Mr. Lovell being considered as of the Virginia Line, and from general Lee's information as to his general policy on this subject, it is probable that the returns made when General Lee was present in command might be different from those made about the end of the War, when from General Lee's absence the command of the Legion had devolved on me.

I hereby Certify that from the records preserved in this Department of certificates issued by Andrew Dunscomb Esquire Commissioner for settling with the Officers and soldiers of the late Virginia line, in the revolutionary Army, it appears that several certificates were issued to Matthew Irvine amounting in the whole to \$1657.13 for the balances due him, and that the book containing the Registry of such certificates is thus headed – "Record of Certificates issued by Andrew Dunscomb Assistant Commissioner of Accounts for the Officers & Soldiers of the Regular Line of the State of Virginia."

Jefferson City March 24, 1807

Sir.

In reply to your Excellency's letter of the 7th instant, I have the honor to inform you that it was my policy to return all the officers & soldiers of my Corps as belonging to the quota of Virginia, because I [indecipherable word]³⁶ deal a service to my native state by increasing the effective Continental force & because I secured to men dear to me better emoluments.

The lapse of time renders it impossible for me to speak positively as to the particular fact you designate, I have therefore referred myself to the officer acting as pay master in the close of the war to my Regiment. His letter I enclose, it leaves me no doubt in my mind but that Doctor Irvine was returned as one of this state's quota & is therefore entitled to the bounty in land allowed to officers of his grade.

This gentleman was very particular friend & I am sure I never could have excepted from out of a general will applied with a view to benefit my officers & soldiers & to aid my own state in procuring the quota of troops but by his order which was not probable & of which I have not the most distant recollection. I conclude with offering my opinion that Doctor Irvine ought to be considered as entitled to the land bounty given by this state to her officers. As to Peter Johnston, I do not recollect but one of that name in my Corps. He was soon promoted to a commission & is well known to you as he has long been a member of the Legislature.
