Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Know all Men by these Presents, that I Peter Robertson executor of Benjamin Jones who was one of the executors of David Walker Junior of the County of Nottoway and State of Virginia – have this day bargained and sold, and by these presents do bargained, sale and assigned over to Thomas D Harris of the County of Henrico and State of Virginia all my right, title and interest in and to two hundred acres of land due to David Walker Junior in consideration of his services in the Army of the United States, to the end of the late war with Great Britain, under the command of Colonel William Davies agreeable to an act of Congress, and I do furthermore requests, order and direct Henry Dearborn Esquire, Secretary War for the time being, or his successors, to issue to Thomas D Harris his heirs or assigns, in his or their own name as assignee of me, the said Peter Robertson executor as aforesaid a warrant for the land aforesaid, and on receipt of the same, I do hereby ratify and confirm any receipt or other instrument in writing, that he the said Thomas D Harris may necessarily signed, or procure to be signed, in touching the premises aforesaid, as fully as I could, if I were personally present. 
