On this 10th day of July A.D. 1855, personally appeared before me, a Justice of the Peace, within and for the County and State aforesaid Mrs. Eleanor Osborn aged 90 years, a resident of the County of Pontotoc in the State of Mississippi who being duly sworn according to law, declares that she is the widow of Alexander Osborn deceased, who was a Colonel in the Rowan Regiment in the War with Great Britain – Revolution – North Carolina – that she was married to said Alexander Osborn in Macklinburg County [sic, Mecklenburg County] NC on the 13 day of February in the year 1786, that her maiden name was Eleanor Lemmon that her said husband died in the year 1828 and that she is now a widow.
