I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

This day William Rawleigh¹ appeared before me a Justice of the peace for the County aforesaid and made oath that Walter Metcalf whose name is mentioned in the within Power of attorney is the same person who performed the service stated within he having enlisted in the 9th Virginia Regiment for the War and continued to the end thereof the said William Rawleigh having been a soldier of the Continental Army and served in the same Regiment.
