Pension application of Littleberry Mosby BLWt64-300 Transcribed by Will Graves f18GA 6/11/09 rev'd 7/24/13

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Know all men by these presents that I Littleberry Mosby Junior late Acting as Captain and Pay master in the second Continental Regiment, State of Georgia under the command of Samuel Elbert during the late War with Great Britain, but now presently residing in the County of Powhatan and State of Virginia, do make constitute and appoint John Davidson of the City of Washington and District of Columbia, by lawful Attorney for me, in my name and in my behalf to receive from the Honorable the Secretary of War, a Warrant for the proportion of Land due me in Consideration of my services aforesaid, and to do all lawful acts requisite full effect being the Premises, hereby affirming and ratifying all that my said Attorney shall do by virtue hereof.

Virginia Powhatan County November 9th 1802

Sir,

From seeing your Advertisement of the 16th of August I have taken the liberty to address you on the subject, and request the favor of your information, -- I was a Captain in the 2nd Continental Regiment belonging to the Georgia line which Regiment was commanded by Colonel Samuel Elbert. I was also appointed pay master to the same, which the returns in your Office will show if they are not destroyed by fire. The greater part of our

Regiment were killed and taken prisoners in the Town of Savannah in December 1778. I was one that was taken and remained a prisoner for 12 months, and then was exchanged for by Major General Lincon [Benjamin Lincoln] who then commanded in Charlestown, who gave me a furlough to return to Virginia for a few months which prevented my being taken again with the balance of the Regiment in Charlestown. -- After the fall of that Town and while I was at home on furlough I received a letter from Mr Jefferson who was then Governor of Virginia requesting made to try and raise as many volunteers as I could & join General Baron Steuben as soon as possible. I raised out of the Militia about 60 men and joined Baron Steuben at Petersburg, and after the battle at Petersburg, I was under the command of General Lafayette until the siege of York, when I met with our Colonel then General Elbert, who told me I might remain at home in Virginia until I should be called for, as we had at that time no men to command, shortly after that, there was an end to the war, and what few Officers and men that belonged to the Regiment were scattered almost through the United States -- what few Officers and men that were in Virginia at the close of the war, who belonged to that Regiment, I am satisfied never did receive their bounty of Land from Congress, for this is the first application I ever made for it. -- if the patent Rolls and Abstracts of pay for the Regiment will be of sufficient voucher of my services I have them now in my possession one of which I have enclosed you, or if a Certificate from a few respectable men in this County will answer a better purpose I can forward one as I know of no superior Officer living whom I could apply to for a certificate of my services, -there are a few Soldiers that belonged to the same Regiment that have made application to me requesting information how they were to obtain their bounty of Lands, I promise, them that I would write you on the subject, Sir you will confer a great favor on me if you will please to inform me by line whether the vouchers spoken of will be sufficient as to myself and what will be sufficient for those that have made application to me.

I do certify that I knew Littleberry Mosby of the Virginia Continental Line – he was a commissioned officer his grade I do not certainly remember – he was in Georgia and perhaps attached to the 2nd Georgia Battalion, but still continued in the Virginia Continental Line – it often happened that officers were attached to the Battalion & troops of other States but they always made returns as belonging to the lines from which they had been transferred – a Regiment of Pennsylvania was attached to Weedon's [George Weedon's] Brigade for a short time, and such periodical [sic] transfers were not uncommon – but it was always understood that no change in compensation was to take place, for the officers had no choice on the subject – being as transferred and attached to other troops by the Commanding Officer at his will & pleasure whenever the service required it. Cumberland [County Virginia] October 28, 1822

This is to certify that I joined the Virginia Continental Line with the late General Littleberry Mosby in the year 1776; that we marched together, and we served 3 years, during which time he conducted himself in an officer like manner. That about the 27th of December 1778 we were taken prisoner at the siege of Savannah and I was sent on board the prison ship where I was confined about 9 months; and Littleberry Mosby on Paroled; and in October 1779 I left him in Savannah as a Captain.

Manchester, 14th March 1822

I do hereby certify that sometime in the year 1776 that the late General Littleberry Mosby of Powhatan County Virginia and myself did enter in the Continental Army about the same time, that we marched together attached to the Second Georgia Continental Battalion for three years, under General Mackintosh [Lachlan McIntosh], Colonel Samuel Elbert, and John Stirk Lieutenant Colonel, that he was Lieutenant to Captain John Mosby's Company: and that on the 17th of December 1778, I left him in the State of Georgia, acting in the capacity of Captain.

Richmond March 15th, 1822

I do hereby certify that I was attached to the Second Battalion in the State of Georgia that General Littleberry Mosby [text to faint to discern] and that about the 29th of December 1778 we were taken prisoners in the town of Savannah and I was sent on board the prison ship, where I was kept for 16 months and General Littleberry Mosby on parole, and that he acted in the capacity of Captain when taken prisoner.
