Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

[p 5: Power of attorney dated March 21, 1801 granted by Hezekiah Morton to John Walls to receive the grant due him from the United States for military services. Morton refers to himself as a resident of Prince Edward State of Virginia and late a Captain in the 3rd Virginia Regiment of the Virginia line on Continental establishment

[p 7: A letter in the file dated May 3, 1907 states the following:

"In response to your letter dated April 10, 1907, and received the 13th ultimo, you are advised that the records of this Bureau show that Hezekiah Morton of Prince Edward County, Virginia, was pensioned under the Act of May 15, 1828, on a certificate issued August 3, 1839, at the rate of \$480 a year, for services as a Captain in the Virginia line on the Continental establishment and died June 30, 1831.

There is no further data on file in regard to said pension."]

[Note: This file does not contain an application under the 1828 act. There is no indication as to what, if anything, has become of that application.]

[From bounty land records in the Library of Virginia] 2 files under the name Hezekiah Morton; the first file contains only 1 page and it is illegibly faint and cannot be read as posted online; the second is a two page file and relates to a Lieutenant Hezekiah Morton who I think is probably the same officer. The papers transcribed below come from that second 2-page file]

I certify that Hezekiah Morton was appointed a Lieutenant in the 12th Virginia Regiment on Continental establishment when under my command early in the year of 1777 soon after which he was detached from the Regiment which renders it out of my power to say how long he continued in service.

Given under my hand this 29th day of April 1808 S/James Wood, formerly B. General

I hereby certify that Hezekiah Morton continued in service of the United States until the end of the war at which time he held the rank of Captain. April 30, 1808
