[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Know all men by these presents that I William Lytle of the County of Davidson and State of Tennessee heir at law to Archibald Lytle deceased a Colonel in the late Continental line of North Carolina do hereby appoint and constitute and empower the Honorable William Dickson² a representative to Congress for the State of Tennessee, my true and lawful attorney for me and in my stead to receive from the Honorable the Secretary of War or any other person Authorized to the delivered the same such land warrant or warrants as the said Archibald deceased was entitled to for his services as a Colonel aforesaid hereby giving to my said attorney full and ample power to do all and every in the premises which I could do were I personally present promising to Ratify and confirm whatever he made lawfully do.

In witness whereof I have hereunto set my hand and seal this 12th day of November 1802



State of Tennessee Davidson County

To all to whom shall see these presents. Know ye that I William Lytle of the County and State aforesaid heir of Colonel Archibald Lytle Deceased, do hereby appoint and by these presents do appoint Doctor William Dickson, my true and lawful Attorney for me and in my name, and for the express purpose of Drawing from the Secretary of Treasury of the United States of America, or from such other person as may be legally Authorized to do the same, the Land Warrant or such proportion of Land that Lieutenant Colonel Commandant Archibald Lytle was entitled to, for his Services in the Continental line of the State of North Carolina, and which was allowed the officers and soldiers in the North West Territory by an Act of Congress, and whereas I the said William Lytle, heir and Devisee of the said Archibald Lytle Deceased do hereby fully authorize and empower the said William Dickson to use all lawful means to draw the said Warrant or proportion of Land that the said Archibald Lytle was entitled to for his Services aforesaid, giving the said Dickson full power and Authority to sign my name and affix my seal to any instrument that may be required of him either by the Secretary of Treasurer [sic], or such other person as may be authorized to settle the same, And it is understood that my said Attorney is hereby vested with express power in transacting and doing the business aforesaid as I possibly could exercise myself were I personally present, promising to ratify and confirm all he made lawfully do in the premises.

In Testimony whereof I the said William Lytle heir and Devisee of Colonel Archibald Lytle hath set my hand & affixed my seal this 13^{th} day of August 1803.

This day appeared John Nichols Esquire before me Thomas Tolbert one of the Justices for the County aforesaid, who made oath that he verily believes and was informed that Archibald Lytle was Lieutenant Colonel Commandant in the Continental line of the State of North Carolina in the late revolutionary War, and that he also believes that William Lytle, who has given a power of attorney to Doctor William Dickson is heir to the said Archibald Lytle Deceased as he this Deponent lived a long time with them in Hillsborough in the State of North Carolina, and that they claimed each other as Brothers, this first day of September 1803

State of South Carolina, Spartanburg District

For the purpose of obtaining the benefit of an act entitled "An Act for the relief of certain officers and soldiers of the Army of the revolution" approved on the 15th of May 1828, I Archibald Litle of the State of North Carolina, Rutherford County, do hereby declare, that I was commissioned a lieutenant colonel in the 6th Regiment, North Carolina (on the 26th day of January 1777, line in the Continental establishment, Colonel Gideon Lamb commanded the 6th Regiment, and served as such to the end of the war.

And I also declare, that I afterwards received a certificate (commonly called a commutation

certificate) for a sum equal to five years full pay, which some was offered by the resolve of Congress of the 22nd of March 1783, instead of half pay for life, to which I was entitled under the resolve of the 21st of October 1780.

And I do further declare, that I have not as a pensioner, received from the United States, since the 3rd of March, 1826, not a cent, nor in any other way, or at any other time.


For the purpose of obtaining the amount of pay accruing to me for the half year ending on the second day of March, 1829, under the act, entitled "An Act for the relief of certain surviving officers and Soldiers of the Army of the revolution," approved the 15th of May, 1828, I John Nelson, formerly of Frankland [sic] County, Tennessee, but now a resident of York District, South Carolina, do hereby declare, that I was a Captain, commissioned as such, in the fourth Regiment North Carolina (in the year 1777) promoted to a major, on the third of February, 1778, and continued in that capacity, to the end of the War. Colonel Thomas Polk commanded said Regiment in the Continental line of North Carolina as was more fully set forth on my application for the benefits of said act, and that I have been found entitled by the Secretary of the Treasury, under that act to the pay of a Captain of Artillery in the said line. Witness my hand, this fifth of March, 1829.
