[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

On this the 10th day of November 1846 personally appeared before me James Hinnant one of the Acting Justices of the Peace in and for said County, Bedeth Allen a resident of Said County of Johnston aged 80 years who being duly Sworn according to Law doth on her oath make the following declaration in order to obtain the benefit of the aforesaid Acts:

That she is the widow of the Thomas Allen deceased who as she has reason to believe and does believe he served in the United States in the War of the Revolution about three years as a Lieutenant:

That she has often heard him tell about the War and about his being under the Command of Captain Steadman. That she has no papers in her possession in relation to the service of her deceased husband. That she was married to the said Thomas Allen some time in the year 1790 and that the said Thomas Allen died on the 3rd day of March 1833, and that her maiden name was Bedeth Killingsworth, and she further insists upon the War Department to allow her of the Pension that was due her husband up to the 3rd of March 1833, and that she further declares that the reason she has not heretofore made application for said Pension is that she was informed that if she was not married previous to the close of the War, she was not be entitled to said Pension. And she further sayeth that she has not intermarried but yet remains the widow of the aforesaid Thomas Allen deceased.

On this night day of November 1853 personally appeared before the Subscriber a Justice of the Peace in and for said County James Braddy[sic] a Pensioner as a Soldier of the Revolutionary War aged 91 years who being first duly sworn according to law doth upon his Oath make the following affidavit --

This affiant Testifies that he knew Thomas Allen well, he lived and died in Johnston County where we both lived when we were not in service he was in Ensign in the year 1777 and a Lieutenant in Captain Stedman's Company and I was in Captain Colman's company both of the 5th Regiment I know the husband of Bedeth Allen is the same Thomas Allen who served in Captain Stedman's company as we were together of before we served in the services and after having rehearsed over since the War our troubles and Sufferings he lived and died in a few miles of me.

On the 10th day of November 1847 personally appeared before me a Justice of the Peace for said County James Stevenson a pensioner of the United States and made Oath in due form of law that he was well acquainted with Thomas Allen Deceased late of this County and knows that he (Allen) served in the Revolutionary war as a Lieutenant some two or three months, and he was afterwards reputed and known to be a Soldier in the Revolutionary war and he knows that he married Bedith Killingsworth who (as he is informed is now applying for the pension that was due her husband &c) and that she has remained a widow ever since his death.

State of North Carolina County of Johnson [sic, Johnston]

On this 28th day of September 1849, personally appeared before the undersigned, a Justice of the Peace in and for said County, Mrs. Bedith Allen, a resident of said County aged 83 years, and widow of Thomas Allen deceased, who being duly sworn according to law, doth declare and say, that she has no papers in her possession showing the exact period of her husband's services in the war of the Revolution and that she can only reiterate what she stated in her Declaration to obtain a pension made by her in November 1846, that she has reason to believe, and does believe that her husband the aforesaid Thomas Allen served in the War of the Revolution about three years. That she always understood from him that he was under the command of Captain Steadman; and that prior to making her said Declaration she had had no search made of the Records at Raleigh for the purpose of finding evidence of her deceased husband's service; nor does she know of any person having made such search. She is therefore unable to "set forth specifically the period of the commencement and duration of each tour of service with the names of the Commissioned and Field Officers under whom" her husband served, as required by the Commissioner of Pensions. She knows that he served, and the Certificates from the Comptroller and Secretary of State of North Carolina prove that fact, and she therefore asks that such pension as she is entitled to may be granted her.
