Transcription of the Revolutionary War Pension Application File for Ambrose Brewer by Foy Varner, Jr.

Source document: Series M805, Roll 118, File R1182 at the National Archives and Records Administration (NARA), Washington, D.C.

[Transcriber's note: This is my transcription of the Revolutionary War Pension Application of Ambrose Brewer (born ca 1753). Ambrose was born in Virginia. At the start of the War, he lived in Cumberland County, NC in the area that later became Moore County, and most of his service was in that area. After 1810 he moved to the area that became Hancock County, Tennessee, and his application was submitted from there in 1854-1855.

I requested a copy of the file from NARA many years ago and did not know at the time that I received only a portion. Chris Chester of the Brewer Surname Project with Family Tree DNA obtained photocopies of the file from Ancestry.com and placed them on the internet at http://brouwergenealogy.blogspot.com/2015/06/the-revolutionary-war-pension-file-of.html. The pictures do not contain all of the pages of the application, but below the pictures is a link to a pdf copy that appears to include all of the file. The various documents are not in chronological order in the file. I also received a partial transcription that was done in 2010 by Will Graves, and it helped me to interpret some areas that were confusing. There are some errors in his version, and there might be some in mine. The various handwriting is sometimes hard to interpret. There is a lot of phonetic spelling, and punctuation is often missing. There are unreadable places where the original documents or microfilm copies were damaged. Some writers mixed lower and upper case letters in places that we would not, and it is sometimes hard to tell which case was intended. There are many extraneous marks on the documents that I assume were unintended. Some were apparently caused by the writer touching the page with his pen, some are the result of ink blotches, and some are the result of bleedthrough from other pages. Thus, it is not always easy to identify punctuation, so I inserted comments in parentheses for clarification. Otherwise, I tried to transcribe the documents exactly as written, and I arranged them approximately in chronological order for better continuity. I separated individual documents by lines of asterisks, and I added some comments after some of the documents.

The application and supporting documents were filed with the state of North Carolina in November 1854 and January 1855 when Ambrose was reportedly about 101 years old. It appears to have been rejected for some unstated reason, but the rejection stamp was apparently placed on the file after 1864, many years after Ambrose had died, so it is likely that the application was not processed until after his death. I will discuss that further below when I describe the file's back cover.

Comments are certainly welcome.

What appears to be the file cover has three columns, one for the state in which the veteran served and to which he applied for pension, one for the veteran's name, and one for the file number. Handwritten in those columns are:

"NC Brewer, Ambrose R1182"

(Note: The Justice of the Peace Ambrose Brewer signed his name and must have been a younger Ambrose Brewer than the veteran. He was probably the man listed in the 1850 Federal Census of Hancock County as age 32, and he was probably a grandson or nephew of the veteran.)

(Note: The position of R. L. Smallwood is not evident from this letter. I assume that he was an official with whom the application was filed and that he in turn had forwarded it to the United States Commissioner of Pensions. He obviously received feedback from the Commissioner as proven by a letter of 25 Jan 1855 below when he submitted further supporting documents.)

He volunteered for a ranger or scout, and so engaged hence he never was in any regular engagement. He is not aware that he ever drawed any pay for his serves (sic), though he received moneys (sic) several times, but he does not recollect for what it was paid him. He has no documentary evidence of his service never having received a discharge as he is aware, but can prove his serves (sic) by one or more witnesses. He here by (sic) relinqushes (sic) every claim to a pension or anuity (sic) except the present, and declairs (sic) that his name is not on the pension roll of the agency of any state. (Note: The service would have been in Cumberland County, because Moore County was formed from Cumberland County in 1784. Be aware that a DAR application reportedly said that Ambrose served under Colonel Cleveland at the Battle of Kings Mountain on 7 Oct 1780, according to "A History of the Hamblen and Allied Families", published in 1940 by or in "Franklin". That participation is suspect without proof, and there is no mention of that engagement in Ambrose's pension application.)

What appears to be the back cover of the file is obviously a form from a much later time that was adapted to enclose Ambrose's application record. At the top right corner is stamped the word "INVALID", which pertains to a disability or invalid pension. Below that and centered is what was probably a title that has been obliterated with ink. Above that and centered is the handwritten number "1182", which is the file number assigned to the application. Below those is a lined-out printed line that lists two "Acts", one of July 1862 and one of March 1864. That indicates that the form is from a much later period. Below that is the handwritten number "1812", which is also lined out. To the right of those items in a vertical orientation is the word "REJECTED", stamped twice, once clearly and once not. Between the two "REJECTED" stamps is what appears to be two or three illegible handwritten letters that are probably initials and are probably an official notation by the person who marked out the items or who stamped the words "REJECTED". Below all of that is the handwritten name "Ambrose Brewer".

(Note: Thus, the application was apparently covered after March 1864 and might not have been processed until that time, which was at least nine years after the application was filed. It appears that Ambrose died in the 1850s after the application was submitted in January 1855. It is not clear to what the number "1812" pertained. It might have pertained to the War of 1812. If Ambrose died before the application was considered, it seems to me that there would have been a notation to that effect. It is possible that he was rejected because he served in the Rangers and was never assigned to a regular unit of the Continental Line. If I understand the original pension law of 1832 correctly, it pertained to members of the Continental Line or state troops and militias, but it seems to me that the Rangers would have been considered as part of those. It might have been rejected because he could not provide documents to prove his service, but it seems that the affidavits of three witnesses would have sufficed. It is also my understanding that approvals were arbitrary and inconsistent by the various authorities, so the rejection might have been inappropriate. The file cover appears to pertain to applications for disability pensions for persons injured in the War, and Ambrose was not applying for a disability pension. We will probably never know the truth.

Three important genealogy-related facts are stated in these documents. One is that Ambrose was born in Virginia. Another is that he was living when the War started in the area that became Moore County, NC. The third is that he served most of the time in that area. If his stated age is approximately correct, he would have been born ca 1753 and would have been only about twenty-three years old when the War started. It is unlikely that he owned land at that age, so he was probably living with some of his family. It is my understanding that men who served as rangers and scouts usually served close to home.

Ambrose's father has not been proven. Family lore reportedly said that Ambrose was a grandson of George and Sarah (nee Lanier) Brewer by one of their sons Howell or Lanier. Records show that the only Brewers living in that area of North Carolina during those years were sons and grandsons of George and Sarah, including their sons Howell and Lanier, and Ambrose later acquired land close to where those men owned land. However, genetic testing has not confirmed that Ambrose was a genetic descendant of George and suggests that Ambrose's genetic father might not have been a Brewer. Thus, it currently appears that Ambrose's familial father was a Brewer but that he or his familial father might have been sired by someone other than a Brewer. The sons of Howell and Lanier have not been proven. It is possible that Ambrose was adopted or that he was a stepson of a Brewer and simply raised as a Brewer.)
