Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later intereenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Columbia SC February 8th 1850

Sir.

In reply to your letter of 8th Ult. in relation to the commutation of Lieutenant Robert Buchanan of 3rd SC Continental Regiment I have to state that our State Archives will show that an Indent "issued to John Buchanan for the Estate of Lieutenant Robert Buchanan of the 3rd South Carolina Continental Regiment the 20th day of November 1783 for one hundred and ninety pounds 19 shillings five pence sterling the amount of his pay and subsistence to the 31st day of August 1780 and for his additional state pay to same time as of certificate from the Auditor General dated the 20th day of November 1783". If as you say his death on 31st of August 1780 would not entitle him to commutation, I beg you to inform me if his legal representatives are not entitle to a half pay for seven years extended to the widows & orphans of officers who died in service, by the resolution of Congress 24th of August 1780, and if so, where did not go to the nieces & nephews of such officers? -- And early answer will much oblige.
