Pension application of Richard Brown R1320 Judah Brown Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Illinois Jackson County SS

On this 7 day of September A.D. 1853, personally appeared before me Judge of the County Court of Jackson in the State of Illinois, in open Court, Court being in session in the town of Murphysboro in said County, Judah Brown a resident of said State of Illinois in the County of Randolph, age 63 years, who after being duly sworn according to law doth on her oath make the following declaration, in order to obtain the benefit of the provisions made by act of Congress, passed February 3rd A.D. 1853, that she is the widow of Richard Brown who was a private Soldier in the Company of Militia men commanded 1st by Captain Godfrey Adams, 2nd by Captain Moore [Francis Moore] to whom command he was transferred after the Battle of Eutaw Springs [September 8, 1781]; during the revolutionary War, in the Regiment of troops commanded by Colonel Middleton [Charles Myddleton], in General Sumpter's [sic, Thomas Sumter's] brigade in the division of the revolutionary Army under the Command of General Greene [Nathanael Greene] in the Revolutionary War (whether he was a regular soldier, and drafted man or volunteer she cannot tell.) Said Richard Brown, resided in the State of North Carolina in either the County of Wilkes or Burke, at the time when he entered the service, which he did about first March 1781, and continued in the service about the space of ten months and was discharged (at what place she cannot tell) about the first December 1781 was in the battles at Dorchester [perhaps the engagement at Fort Dorchester, December 1, 1781] and Eutaw Springs. She further declares that she was married to the said Richard Brown in said Jackson County State of Illinois in the month of March in the year 1822 and that her said husband, the aforesaid Richard Brown died in Franklin County in said State on the 15th day of March A.D. 1828, that she was married to him at the time above stated. She further swears that she was a widow at the passage of the act, and is still a widow and that she has never before made application for a Pension. She further says that she knows of no documentary evidence by which he can prove anything about the services of her said husband, save the rolls of the Army. She further swears that she is unable to obtain any record evidence of her marriage with the said Richard Brown. The clerk's office in said Jackson County having been destroyed by fire in 1843 the record of their marriage was burned, and they never had any family record.



Know all men by these presents that I Ritchard Brown [sic] of the North Carolina State have this day Bargained and Sold to Andrew Alexander of the same place an Indent of Eighty pounds Sterling which he is entitled to from the State of South Carolina for his services done in the State Troops in General Sumter's Brigade Colonel Midleton's [sic] Regiment Captain Mores [sic] troop for the consideration of one pound [text blotted out] paid for which draw [?] I warrant & defend from all other persons to said Alexander. Given under my hand this 25th day of January 1786

Please to pay John [text blotted out and rendered illegible] or order the indent of eightyfour pounds Sterling and the interest thereon it being for my service as a light Dragoon under
Command of General Sumter and this my order shall be your receipt in full for the same.

Richard Brown made oath before me a Justice for said County that the above account is Just and true and that he never sold or traded the above Indent or any pay to any person but John [surname blotted out] and [text blotted out] from him for the [indecipherable word]. Sworn before me this 24th day of November 1790
