Pension application of John Colwell (Caldwell) R1590 Elizabeth fn38NC Transcribed by Will Graves 11/29/10

State of North Carolina Sampson County: Court of Pleas and Quarter Sessions November Term 1845

On this the 17th day of November 1845 personally appeared before the Court of Pleas and Quarter Sessions for the said County of Sampson Richard Caldwell a resident of the aforesaid County and State aged 59 years who being duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed July 7th 1838 for the benefit of certain widows.

That he is the son of John Caldwell deceased of the said County and State, who served in the United States in the war of the Revolution as an enlisted soldier for three years. The declarant states on his said oath that his father the said John Caldwell served out the said enlistment faithfully and was honorably discharged.

That the said discharge was placed in the hands of Patrick Murphy of the said County for the purpose of getting a Pension who states that he is not certain where it is. That he thinks that he sent the said discharge Congress to the Honorable James J McKay and that perhaps it may be on file in the Pension Office.

The declarant further states that the said John Caldwell was married to Elizabeth Spell on the 14th of January 1783.

That his father the said John Caldwell died the 28th of October 1829, leaving surviving him, Elizabeth Caldwell (his widow) who died on the 24th day of August 1838 leaving surviving her five children to wit the declarant Richard Caldwell, Mary who intermarried with Zacheus Mathis, Catharine who intermarried with Stephen Herring, Margaret Caldwell and John Caldwell only surviving heirs of the said John and Elizabeth Caldwell and all of lawful age.

In support of the said marriage the declarant here with sends his father's original Family Record and that the said record he believes is in his Father's own hand-writing.

Sworn to and subscribed on the 17th day of November 1845 in open Court.

I, William Hill, Secretary of State, in and for the State of North Carolina, do hereby certify, that it appears from the muster-rolls of the Continental line of this State, in the Revolutionary War, that John Colwell a private Soldier in Captain Tartanson's ¹ Company of the eighth Regiment, entered the service on the 12th day of March 1777 for the term of three years and that he drew a Warrant for bounty land for fifty one months service in May 1784.
