[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Certificate

John William Ludemann, who was born in this place and who died in the year 1786 as an Officer of the United States of America at Richmond Virginia, has left as his nearest heirs, his only two sisters, to wit:

- 1. Christine Sophie Ludemann, married to Hampe
- 2. Catherine Juliana Ludemann

whom he has also mentioned in his will dated: Richmond the 1st March 1786

It is further legally certified, that the children of the oldest sister of Ludemann, named under No. 1 Christine Sophie married to Hampe are as follows

- 1. Anna Christine Hedwig the widow of the deacon Gold, with Schodde off this place
- 2. Henrietta Magdalene the widow of the deceased Inspector Reichard
- 3. Christine Sophie, the widow of the deceased Dr. Jus: Kahl, Hall from this place, who are after the childless decease of their other sisters, the only soul heirs of their mother, Christine Sophie Ludemann married a Hampe.

All this is certified by reason of testimony heard Munden the 1st of October 1850 The City Court of the City of Munden

1. In the year 1750 the fifth July was born and baptized on seventh instant a daughter who was named Christine Sophie, unto Mr. Rudolph Ludemann and on to his wife Anna Christine by birth Bearman [?]

Officially testified Munden the fourth of December 1859

- 2. In the year 1754 the 14th of July was born unto Mr. Rudolph Ludemann and on to his wife Anna Christina, by birth Beurmann, a son who was baptized on 17th the same and named John William officially testified Munden the fourth of December 1859
- 3. In the year 1856 the fourth May was born unto Rudolph Ludemann and on to his wife Anne Christine Hedwig by birth Beurmann, a daughter who was baptized on sixth instant and named Catharine Juliane
- 4. In the year 1774, 13th of September was born unto Mr. Franz William Hampe and on to his

wife Christine Sophie by birth Ludemann, a daughter, who was baptized the 16th instant and named Anna Christina Hedwig, Sponsor Mrs. Knieriem in place of grandmother.

5. In the year 1788, the 22nd May was born unto Mr. Franz William Hampe and I do his wife Christine Sophie, by birth Ludemann, a daughter who was baptized on 26 instant and named Henrietta Magdalina. Sponsor Henrietta Hampe and Miss Anna Magdalina Elizabeth Ludemann six. In the year 1790 the third April, the wife of Mr. Citizen Delegates and church elder Franz William Hampe Mrs. Christina Sophie by birth Ludemann, was delivered of a daughter, who received at the holy Baptism on fifth the names Christine Sophia. Sponsors the grandmother of the child Mrs. Anne Christine Hedwig Knieriem of the flower.
