Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

[Note: There are no documents of any substance in this file. There is one letter dated May 28 1852 sent from John Gammel, Administrator of the estate of Massenburg, to J. E. Heath, then the Commissioner of Pensions in which Gammel makes reference to depositions given in the case by a Mrs. Paine, but those depositions are not in the file. There is nothing in the file that indicates where the substantive documents might be located.]

The Heirs of Alexander Massenburg who was a Midshipmen in the State Navy of Virginia, in the War of the Revolution; respectfully submit their claim for Land Bounty to the Executive; and beg leave to refer to the Report of the "Commissioner" John H Smith Esquire, in support thereof.

I William Jennings² of Hampton aged eighty-two years, do hereby certify that I served as a Seaman in the Virginia Navy in the Revolutionary War and knew Alexander Massenburg of Hampton both in and since said War. – Said Massenburg served as first midshipmen on board the *Liberty* a vessel of the Virginia Navy in the Revolution. I cannot state the exact time of his service, but have no hesitation in stating that he served more than three years, and until the *Liberty* was taken from out the Service.

Given under my hand this 26 day of June 1835.

Ordered that a warrant issued to Alexander Massenburg for nineteen pounds four shillings for his wages on Board of the Brig *Liberty* to the 5th next as per certificate of Captain Lisley [?].

The affidavit of Commodore James Barron³ of the United States Navy made before me a Notary Public duly commissioned & qualified

The Affiant being duly sworn stated that he was well acquainted with Alexander Massenburg of Hampton Virginia – that the said Massenburg was a Master in the Virginia Navy during the Revolutionary War. This Affiant does not certainly know when the said Massenburg entered the service, but his impression is that from 1779 until the close of said War, the said Massenburg served as a Master –

The affiant also states – that he was well acquainted with George Coray he was a Midshipmen in said service and served as such until the close of said Revolutionary War.

State of Maryland City of Baltimore, to wit

On this 12th day of March in the year of our Lord 1838 before me the subscriber one of the Justices of the Peace in and for the City of Baltimore personally appeared Armistead Cully⁴ who being duly sworn on the Holy Evangelists of Almighty God deposeth and saith that he entered in the service of Virginia in the early part of the Revolutionary War in Captain William Smith's Company and he was afterwards transferred to the Virginia Continental command by Charles Tomkies [Charles Tompkins?] and took part in the Siege of York when Cornwallis surrendered [October 19, 1781] to the American troops, the deponent was born in the County of Mathews in the State of Virginia and was brought up to the business of a ship Carpenter which he followed until his removal to the City of Baltimore in the year 1818, or thereabouts, and his residence has continued here ever since, the deponent was well acquainted with Robert Cully who was an older brother of his, he served in the State Navy of Virginia on board of the Brig Liberty⁵ as the chief Carpenter, which vessel was first commanded by Captain Thomas Lisly

[Thomas Lilly] afterwards by Captain George Rogers when she was captured by a British Cruiser and carried to Halifax, the said Robert Cully was on board of her at the time as Carpenter and did not return from captivity until about the year 1780. Among the officers attached to said Brig with whom this deponent was well acquainted at the time of his capture were Alexander Massenburg of the Town of Hampton who was a Midshipman, and Doctor Joseph Harrison the Surgeon of the said Brig – the said Rogers and Harrison died in prison, Massenburg subsequently served in the Henry Galley commanded by Captain Robert Tompkins, he thinks as master – The Brig Liberty was a large man of war Brig and mounted several guns probably as many as 18.
