Pension application of Thomas Allman (Almond) R164 Judy Allman f21NC

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## State of Missouri County of Niangua: SS

On this the 16<sup>th</sup> day of September 1844 personally appeared before the undersigned an acting Justice of the Peace in and for said County Judy Allman, a resident of the house of her son Nathan Allman, in said County, aged eighty years who being first duly sworn according to law doth on her oath make the following Declaration in order to obtain the benefit of the act of Congress passed the 4<sup>th</sup> of July 1836 granting pensions to certain widows of Revolutionary Soldiers:

That she is the widow of Thomas Allman, who was soldier in the Revolution for nine months. She states that she was married to Thomas Allman on the 11<sup>th</sup> day of November in the year 1780 in Montgomery County North Carolina by the name of Judy Holland. That her husband Thomas Allman entered the service of the United States from Orange County North Carolina early in the year 1781, the precise time of said year she cannot state but thinks it was the first of the year above mentioned, under Captain Rodes and Colonel William Lytle. She states that he was engaged in said service under the above officers on Deep River and while guarding the Tories at Hillsboro North Carolina. She states that her said husband was on Deep River three months and six months engaged in guarding the Tories at Hillsboro. Said Allman obtained a discharge from Colonel Lytle but in crossing a watercourse sometime afterwards, his saddle bags were washed from under him and lost; said Discharge was in the said Saddle bags and also lost. She states that her said husband, Thomas Allman, died in Marion County State of Illinois on the 20<sup>th</sup> of August 1837. She states that just previous to her husbands death that he was about trying to procure a pension.

State of Missouri County of Niangua: SS

On this the 16<sup>th</sup> day of September 1888 personally appeared before the undersigned an acting Justice of the Peace in & for said County Ferbey Peake a resident of said County aged Seventy Seven years, who being first duly sworn according to law doth on her oath depose and say: That she is the sister of Judy Allman formerly Judy Holland, that she was present when Judy Holland married Thomas Allman in Montgomery County North Carolina sometime in the year 1780. She also states that Thomas Allman was a soldier of the revolution.

Supplemental Declaration of Judy Allman alias Almond State of Missouri County of Dallas, formerly Niangua: SS

Personally appeared before the undersigned an acting Justice of the peace in and for said County Judy Allman alias Almond aged 80 years who being duly sworn according to law doth on her oath make the following Supplement to her Declaration of September 1844 for a pension. She states that she is uneducated and does not know now nor did she know when she made her Original Declaration how her husband the late Thomas Allman alias Almond spelt his name that she supposes that said name was spelled in her declaration to suit the sound or pronunciation of the same she further states that when her Original declaration was prepared that her son Nathan Allman alias Almond was not at home and that she had no means of consulting any person who could give her the correct spelling of said name neither did she know that the proper spelling of said name would make any difference. She further states that since being informed that the name Thomas Allman cannot be found upon the Revolutionary records in Raleigh North Carolina and that the name of Thomas Almond can be found upon said records as having rendered service in the State of North Carolina during the Revolution and knowing of her own knowledge that her late husband was engaged in said service for nine months she has been induced to make inquiry how her husband did spell his name and she has since learned he spells it Almond and not Allman.
