I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

[Power of attorney dated November 2<sup>nd</sup>, 1833 executed by John Sinclair under which he states that he is the husband of the granddaughter of Colonel William G Munford. The power of attorney was executed in Gloucester County Virginia. The document authorizes the attorney to pursue the commutation pay due Colonel William G Munford.<sup>2</sup>
