Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." I hereby certify that I have examined the claim of the legal representatives of John Piper, deceased, who was a Lieutenant in the first Regiment of the Virginia State Line; that he served as such until the year 1780, when he became a Supernumerary Officer; that he died in May 1814; that the case is embraced by the provisions of the act of Congress of the 5th of July 1832, entitled "An act to provide for the liquidating and paying certain claims of the State of Virginia;" that the claim shall therefore be allowed at the rate of \$160 per annum, from the 31st of December 1780 up to the first of May 1814; and that the amount is payable to the Honorable John B Thompson, attorney of Amos Yantis of Kentucky, administrator of the said John Piper, deceased.
